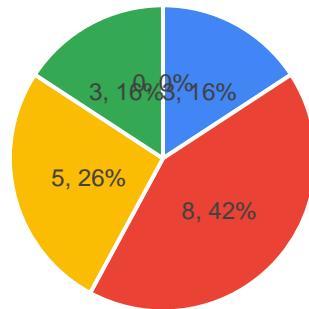

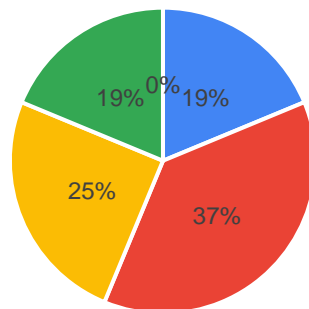

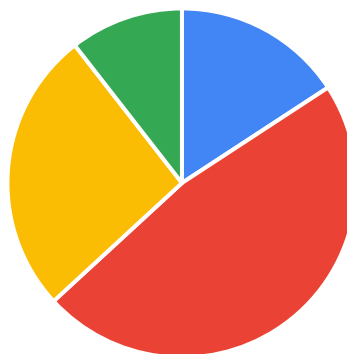

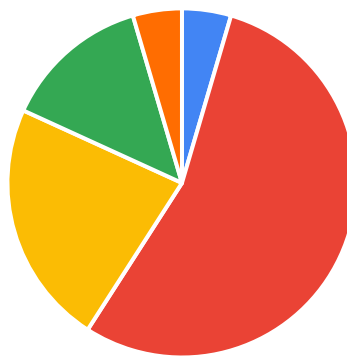

Employers' Feedback on Curriculum Evaluation

The feedback from employers reflects a generally positive perception of the curriculum's alignment with educational and professional needs. Most respondents agreed that the Programme Outcomes (POs) and Course Outcomes (COs) meet current demands, though a few neutral or disagreeing responses indicate potential areas for enhancement. The curriculum is praised for maintaining a good balance between theory and application, which is vital for preparing students for real-world challenges. Additionally, the curriculum effectively instills ethical values and supports employability, with a majority agreeing that it has helped students secure jobs or pursue higher education.

While employers acknowledged improvements in students' communication and interpersonal skills, some responses suggested a need for further focus in these areas. The curriculum also promotes independent thinking and leadership skills, though its impact on self-learning and overall development received mixed feedback. These insights highlight the strengths of the

curriculum while pointing to opportunities for refinement, especially in enhancing engagement, skill-building, and self-directed learning capabilities.
