Implementation Strategy of Grievance Redressal and Anti-Ragging Cell

The Institution has a transparent mechanism for timely redressal of student related grievances. The institution ensures solutions to the issue of grievances. The concerning committee discusses issues related to students.

Implementation of guidelines of statutory regulatory bodies

The grievances are collected through offline mode. Grievances can be given either through complaint box or can be handover directly to the concerned committees (the Grievance Redressal Cell / Sexual Harassment and Anti- ragging cell). The mechanism behind ragging related issues on the campus is according to the rules of UGC, MHRD and GOI. A three-tier system of Grievance Redressal Cell. functions at the Tutor level, HOD level and the Principal level to address the student's grievances is working in the college. Though no such Ragging and or Sexual harassment cases were reported on the campus, as the Committee is organized regularly. Instructions in the form of code of conduct are displayed on the college website.

Mechanism for submission of complaint against Ragging

The Anti-ragging cell for the welfare of students is constituted at the beginning of the academic year. The committee is constituted as per the direction of the Supreme Court with members including the Principal, District Collector, Circle Inspector of Police, media person, social worker and teaching faculties. The committee's main aim is to create awareness among students regarding the consequences of ragging. So, this committee organizes awareness classes regarding ragging and related punishment.

MECHANISM: There exists a systematic mechanism to prevent ragging in the institution. The Anti-ragging cell gives awareness classes for students. During admission time an undertaking regarding ragging is collected from every student and his/her father/guardian. Rules and regulations of our college are uploaded on our website.

Mechanism for submission of student's grievances and Sexual Harassment

POLICY: A grievance redressal cell is constituted at the beginning of every academic year. The cases related to Sexual harassment are also addressed under this committee. The main objective of this committee is to discuss the grievance in detail and to find an unbiased solution within a short period of time.

MECHANISM: The grievance is filed through offline mode -direct method, by giving directly to committee members and through complaint box. All cases are discussed and resolved within a period of short time.
